

A RESOLUTION HONORING M. DOUGLAS ANDERSON  
FOR TWENTY – ONE YEARS OF FAITHFUL SERVICE  
AS CITY ALDERMAN, WARD TWO

Douglas Anderson, of Galva, Illinois, was born on 27 May, 1958, in Galesburg, Illinois, to Douglas and Marsha Anderson; he is married to Dawn (Johnson); he has one brother, Chris; he has two children, daughter Lily and son Clayton; he graduated from Galva High School in 1976, attended Black Hawk East College, Western Illinois University and Illinois State University where he received his baccalaureate degree in Political Science in 1980; and

WHEREAS, Alderman Anderson worked for the Galva Creamery from 1974 until 1981; he ran his own construction business from 1980 until 1987; he was Superintendent of the Galva Park District from 1982 until 2001; he worked for the Dixline Corporation from 1982 until 2000; he was employed by Scrip, Inc. from 2000 until 2012; and he has been employed by AC McCartney from 2012 until the present time; and

WHEREAS, Alderman Anderson served his community as a volunteer in the Galva Fire Department for ten years; served as a board member on the Henry County Economic Development Partnership for three years; found the time to serve the youth of the community as a Cub Scout and Assistant Boy Scout Leader; and then determined he had a bit more to give by allocating generous portions of his time to coach baseball, basketball, soccer and flag football for Galva youngsters in their formative years; and

WHEREAS, Alderman Anderson is a member of the Messiah Lutheran Church of Galva; and

WHEREAS, Alderman Anderson was duly elected to the Galva City Council by the members of his Ward in 1993; and

WHEREAS, Alderman Anderson, after twenty-one years of unwavering and faithful service to the City of Galva and the citizens of his Ward did resign his position as Alderman, Ward Two, on 20 January, 2014; and
